2. Principal's Report - Jay Salter:
 - a. 260 graduates visited their old elementary and middle schools for Grad Walk. Caps & Gowns have been distributed. We have a 90% graduation rate at the school. Graduation will be held on June 11th. Extra graduation tickets should be turned in by next Friday to Dana. Heather is keeping a list of requests for additional tickets.
 - b. Starting next school year, counselors will be assigned by Graduation cohorts.
 - c. Next year, internships for high school credit opportunities will be offered.
 - d. We expect enrollment to be about 1360 students next year. More students equals more teachers so we are not expecting any loss of allocated teachers and we will have 3 art teachers next year. We expect around 326 seniors next year.
 - e. Galena Outdoor Academy is going to Project Discovery. If we get 120 students enrolled we can have a real school and not just a 7th period/passion group.
 - f. Meeting discussion - A question was asked about how we can prepare students for college. Could we bring someone in to explain things like college study habits, professor office hours, etc. Mr. Salter has a friend at UNR, Joe Nannini, that he will reach out to and see if he can help facilitate something like that.
 - g. Parking spot sales for student parking 2026/2027 have sold out. There will be an additional 26 spots opening up. Parking spots are sold for \$100 each. Visitor parking is now available and is marked in the front by white paint on the curb.
